APPEAL FOR IMMEDIATE RELIEF TO RESTAURANT INDUSTRY IN VIEW OF THE CORONA VIRUS

Dear Sir,

1. Greetings from National Restaurant Association of India. NRAI is the Indian Restaurant Industry's leading Association. Founded in 1982 and headquartered in Delhi, we are the voice of the restaurant industry representing the interests of 5,00,000+ restaurants pan India. The restaurant industry, with an annual turnover of ~ INR 4 Lakh Crore is the third largest after retail and insurance in the service segment, providing direct employment to over 7 million Indians.
2. We would firstly like to thank the Government for its proactive steps in combating the COVID-19 pandemic, including the ongoing lock down measures across the country.
3. While we all sincerely hope for a quick normalisation of the situation, we would like to state that the food service industry, already battling through tough times for the past couple of years, is now facing a challenge of mere survival under the present circumstances. We are staring at unmeasurable losses, prospect of several businesses closing down and most importantly, a scary spectre of job loss to millions in the sector employing more than seven million people.
4. Under these extraordinary circumstances due to the COVID-19 situation, we are not sure of what the future holds in terms of business conditions / continuity for many in the industry. It will take at least six months for the basic recovery of the business – after the situation gets back to normal. We therefore seek your immediate assistance in the following manner as mentioned below:

(a) Request for extending the existing licenses/registrations for restaurants for a period of six months from 01st April 2020 onwards. This will give all stakeholders adequate time to complete the required processes once the situation normalises and businesses start operations again.

(b) We also request for extending the payment dates for all electricity, water and property/other taxes by six months from 01st April 2020 onwards.

5. In view of the above stated facts, we again humbly request you for your kind consideration and favourable action on the above suggestions. We reiterate that in this unprecedented situation, these are critical requirements for the immediate survival and subsequent revival of the restaurant industry.
