District Guidelines- GB Nagar

Based on the order of UP Govt no.1382/2020 dated 31-05-2020, the following guidelines shall be applicable for GB Nagar :-

1. Permitted activities and prohibited activities shall be as per the MHA and State guidelines
2. Noida Delhi border - Health department has given a report today in which it states, In the last 20 days, of all the covid positive cases, In 42 percent of the cases, source of infection has been tracked to Delhi. Therefore, after consultation and consent of Health and Police departments, it has been decided in public interest that status quo shall be maintained with respect to interstate border.
3. As per the state Guidelines with respect to opening of Shops/Bazaar, previous directions issued in district shall remain the same. In urban areas, as before, 50 Percent of the shops shall be opened everyday in alternating manner. Based on request of shop keepers and Vyapar mandal, Labour department has been directed to modify and notify weekly holiday, separately after consultation with the stake holders.
4. Incident commanders, police and Health teams shall redefine the containment zones as per new directions as described below:
5. Residential areas:
 - A- In case of multi storied residential buildings/societies the following rules shall apply with regards to the containment zones:-
 - If one or multiple cases in a tower situated in a multi story society, that particular tower where active case/cases have been found shall be designated as containment zone.
 - However, if cases are found in more than one tower in a society, all such towers where active cases have been found along with all such common facilities like park, gym, swimming pool, banquet hall, etc.. shall form containment zone
6. Commercial/Industrial/Office premises:
 - A- If cases are found in a particular area, where the patient(s) was actively working, then all such areas shall be closed for the purposes of sanitisation and disinfection to prevent the spread of disease, for a period of 24 hours. The occupant of such premises shall bear the cost of sanitisation and shall carry out sanitisation process as per the covid protocol.
 - B- If commercial/industrial/office premises are located in a multi storied building,
 - if cases are found in a single floor, then that particular floor shall be closed.
 - if cases are found in more than one floor, then the whole building shall be closed for such period and till such conditions are met as stated above in point 6 'A'
7. All Industrial activities are allowed outside containment zone. They are mandated to follow all precautionary protocols.
8. All activities permitted as per MHA/State guidelines shall be allowed. There is no requirement of any separate pass or permission to carry out such activities.
